RESOLUTION NO. 1183

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ACCEPT
THE DONATION OF 12 FLOURESCENT LAMPS OF 20 WATTS EACH WITH
WEATHER SHIELD FROM THE SANGGUNIANG BARANGAY OF LINAO
FOR INSTALLATION ALONG THEIR BARANGAY ROAD AND THANKING
THE LINAO SANGGUNIANG BARANGAY FOR THEIR WORTHY DONATION

"WHEREAS, the Sangguniang Barangay of Linao by its Resolution No. 1 dated June 11, 1982, had signified its intention to donate 12 units of fluoresecent lamps of 20 watts each with weather shield which they would like to be installed along the barangay road of Linao not to exceed 250 watts in line with the policy of the Sangguniang Panlungsod even as the Barangay recognizes its duty to maintain said lighting equipment in tip-top condition;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Tugonon; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the donation of 12 units of fluorescent lamps of 20 watts each with weather shield from the Sangguniang Barangay of Linao for installation along their barangay road and do, as this Body hereby does, thank the Sangguniang Barangay for their worthy donation which will go a long way to the progress and prosperity of Barangay Linao in particular and the general well-being of the people of Ormoc in general;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the City Treasurer, the General Manager and the Board President of LEYECO V, and the Sangguniang Barangay of Linao, all in the City of Ormoc;
