RESOLUTION NO. 1184

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO SIGN THE DEED
OF ABSOLUTE SALE WITH MR. AND MRS. BENJAMIN PARRILLA COVERING THE
LATTER'S LOT NO. 2263-A WITH AN AREA OF 1,725 SQUARE METERS
AFFECTED BY THE CONSTRUCTION OF THE BARANGAY ROAD CONNECTING
BARANGAY DOÑA FELIZA MEJIA TO DON FELIPE LARRAZABAL STREET

"WHEREAS, a deed of absolute sale is now being prepared for signa-
tures of the Honorable City Mayor, for and in behalf of the City Govern-
ment, and Mr. and Mrs. Benjamin Parrilla covering the latter's Lot No.
2263-A with an area of 1,725 square meters affected by the construction
of the barangay road connecting Barangay Doña Feliza Mejia to Don Felipe
Larrazabal Street at the rate of ₱30.00 per square meter for which
the amount of ₱51,750.00 had already been set aside pursuant to Reso-
lution No. 1162 dated June 1, 1982;
