RESOLUTION NO. 1186

A. RESOLUTION EARNESTLY REQUESTING THE DIRECTOR OF FOREST DEVELOPMENT THAT WHERE FORESTS, SWAMPS AND OTHER NATURAL RESOURCES ARE WITHIN THE TERRITORIES OF BARANGAYS IN THE CITY OF ORMOC ALL PUNONG BARANGAYS THEREOF SHALL BE DEPUTIZED AS LOCAL FORESTERS TO ASSIST THE DISTRICT FORESTER IN THEIR RESPECTIVE TERRITORIAL JURISDICTION AND AREAS OF RESPONSIBILITY

"WHEREAS, barangay captains, now officially called 'punong barangays', with forests, swamps and other natural resources within their territorial jurisdiction are powerless to check rampant illegal logging or cutting of trees in their areas of responsibility as in the case of punong barangays of Liberty, Quezon Jr., Mahayahay, Gaas, Cabawon-an, Tuñgonan, Cabingtán, Milagro, Can-untog, Borok, San Juan, Lao and Mas-in on account of the fact that they are not authorized to look into the operation of loggers;

"WHEREAS, it would be to the greater benefit and welfare of these barangays in particular, and the City of Ormoc in general, were the punong barangays concerned authorized to look into logging operations in their respective territories such that any illegal cutting down of trees can immediately be checked with authority and thus prevent wanton denuding of our forests;

"WHEREAS, granting authority to punong barangays by way of deputizing them as local foresters to watch over our natural resources in their areas of responsibility for and in behalf of the District Forester or the Director of Forest Development where the barangays can oversee not only the gathering of logs or lumber but also the program of reforestation;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request the Director of Forest Development that where forests, swamps and other natural resources are within the territories of barangays in the City of Ormoc as in the case of Barangays Liberty, Quezon Jr., Mahayahay, Gaas, Cabawon-an, Tuñgonan, Cabingtán, Milagro, Can-untog, Borok, San Juan, Lao and Mas-in, all punong barangays thereof shall be deputized as Local Foresters to assist the District Forester in their respective territorial jurisdiction and areas of responsibility; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Director of Forest Development, Region VIII, Tacloban City, the Officer In-Charge, Bureau of Forest Development, and the Punong Barangays of Liberty, Quezon, Jr., Mahayahay, Gass, Cabawon-an, Tugonon, Cabingtan, Milagro, Can-untog, Borok, San Juan, Lao and Mas-in, all in the City of Ormoc;


