RESOLUTION NO. 1187

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, PRESIDENT
FERDINAND B. MARCOS, TO RELEASE THE 31 HECTARES OUT OF
LOT NO. 10851, A PUBLIC LAND IN SITIO CAMBANTUG, MILAGRO,
ORMOC CITY, UNDER LEASE APPLICATION OF THE CITY GOVERNMENT,
FOR PURPOSES OF THE CITY NURSERY AND FOR THE INTEGRATION
AND PROSECUTION OF THE "PAGKAIN NG BAYAN" PROJECT IN LINE
WITH THE "KILUSANG KABUHAYAN AT KAUNLARAN" (KKK) PROGRAM

"WHEREAS, the Bureau of Lands had already segregated some 31
hectares of Lot No. 10851, a public land situated in Sitio Camban-
tug, Barangay Milagro, Ormoc City, for purposes of establishing
the City Nursery thereat where we can integrate and prosecute the
'Pagkain ng Bayan' project even as we endeavor to implement the
National Livelihood Program, otherwise known as the 'Kilusang Ka-
buhayan at Kaunlaran' envisioned by the President to become the
centerpiece of the development strategy of the New Republic;

"WHEREAS, the parcel of land applied for has been referred
to the PNOC Energy Development Corporation by the District Land
Officer which application, according to the letter of the Project
Manager, Engr. Ernesto B. Patanac, of the Leyte Geothermal Pro-
ject, dated March 1, 1982, copy of which is hereto attached as
Annex 'A' hereof, has been favorably acted upon;

"WHEREAS, we are in receipt, however, of a letter dated 24
March 1982 of Mr. Mario C. Berbano, Manager, Environmental Ma-
nagement Department, PNOC, to the effect that up to the present
there is no guideline yet in connection with the management and
granting of permits on the reservation area for the vegetable
nursery project of the City Government, a copy of which letter
is hereto attached as Annex 'B' to this Resolution;

"WHEREAS, acting on the advice of Engr. Felipe S. Sison,
Acting District Land Officer, Bureau of Lands, District Land
Office No. VIII-I, Tacloban City, per his letter dated 12 April
1982 a copy of which is hereto attached as Annex 'C', we would
like to ask for clearance from the Office of the President to
the effect that the City Government can avail itself of this
area for the purposes herein stated;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly by Mga Kagawad Bandalan and Hermosilla; be it

"RESOLVED, to earnestly request His Excellency, President Ferdinand E. Marcos, to release the 31 hectares out of Lot No. 10851, a public land situated in Sitio Cambantug, Barangay Milagro, Ormoc City, under lease application of the City Government, for purposes of the City Nursery for the integration and prosecution of the 'Pagkain ng Bayan' project in line with the National Livelihood Program, otherwise known as the 'Kilusang Kabuhayan at Kaunlaran' (KKK); and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each, together with all the annexes, to His Excellency, President Ferdinand E. Marcos, and the Honorable First Lady and Minister of Human Settlements, Madam Imelda Romualdez-Marcos, both in Malacañang, and the Honorable Minister of Natural Resources Teodoro Peña, all in Metro Manila; Engr. Felipe S. Sison, Acting District Land Officer, Bureau of Lands, and Dr. Pedro D. Destura, Area Manager and Regional KKK Action Officer, Ministry of Human Settlements, both of Region VIII, Tacloban City; Engr. Ernesto B. Patanao, Project Manager, Leyte Geothermal Project, and Engr. Mario C. Berbano, Manager, Environmental Management Department, both of the PNOC, Tugonon, Ormoc City;
