RESOLUTION NO. 1188

A RESOLUTION TO FAVORABLY ENDORSE THE REQUEST OF THE KABATAANG
BARANGAY FEDERATION TO THE HONORABLE CITY MAYOR FOR APPROVAL
OF THEIR ORIENTATION SEMINAR AND GENERAL MEETING ON AUGUST
7, 1982, AT THE HON. PLACIDO C. ENECIO HALL, SANGGUNIANG
PANLUNGSOD BUILDING, AND TO RECOMMEND FINANCIAL AID THEREFOR

"WHEREAS, the President of the Kabataang Barangay Federation,
in her letter of July 12, 1982, conveyed to this august Body their
decision to hold an orientation seminar and general meeting at the
session hall (Hon. Placido C. Enecio Hall) of the Sanggunian Build-
ing for which they seek a favorable recommendation from this Body
to the Honorable City Mayor for approval and, also, requested for
