RESOLUTION NO. 1190

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, PRESIDENT
FERDINAND E. MARCOS, AND THE HONORABLE FIRST LADY, MME.
IMELDA ROMUALDEZ-MARCOS, FOR ADDITIONAL ALLOTMENT OF ANY
AMOUNT THEY DEEM APPROPRIATE FOR ORMOG AS A FIRST CLASS-B
CITY FOR THE KKK-LOCAL GOVERNMENT SPECIAL FUND AS THE
INITIAL RELEASE HAD ALREADY BEEN EXHAUSTED

"WHEREAS, the City KKK Action Officer reported that based on
the latest release and computation of the City Treasurer the KKK-
Local Government Special Fund (LGSF) allotment of P100,000.00 had
already been exhausted last week;

"WHEREAS, it has become urgent to ask for additional allot-
ment from His Excellency, President Ferdinand E. Marcos, and the
Honorable First Lady and Minister of Human Settlements, Madam
Imelda Romualdez-Marcos, in their capacities as Chairman and Sec-
retary General, respectively, of the Pambansang Lupong ng Kilu-
sang Kabuhayan at Kaunlaran, of any amount which the First Couple
of the Land may deem appropriate for Ormoc as a First Class-B
City, considering that what we received last was an allotment
equivalent for lower-class municipalities;

"WHEREAS, it has been found out that the KKK-LGSF allotment
for the City of Ormoc has, indeed, benefited quite a number of
people in this locality;

"WHEREAS, additional allotment will enable the City Adminis-
tration to help more priority beneficiaries in the community;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded by
Kagawad Torre Villas; be it

RESOLVED, to earnestly request His Excellency, President
Ferdinand E. Marcos, and the Honorable First Lady and Minister
of Human Settlements, Madam Imelda Romualdez-Marcos, for addi-
tional allotment of any amount which they deem appropriate for
Ormoc as a First Class-B City for the KKK-Local Government Spe-
cial Fund (LGSF) inasmuch as the previous and initial release of
P100,000.00 had already been exhausted; and be it
