RESOLUTION NO. 1191

A RESOLUTION REQUESTING HIS EXCELLENCY, PRESIDENT FERDINAND E. MARCOS, THROUGH THE HONORABLE JOSE A. ROÑO, MINISTER OF LOCAL GOVERNMENT, TO APPOINT ATTY. INAKI P. LARRAZABAL, JR., KAGAWAD NG SANGGUNIANG PANLUNGSOD NG ORMOC, VICE - KAGAWAD PLACIDO C. ENOCIO, DECEASED

"WHEREAS, there has been existing for the last couple of years a vacancy of the position of Kagawad ng Sangguniang Panlungsod ng Ormoc following the death of Kagawad Placido C. Enocio;

"WHEREAS, it has been the desire of this august Body to recommend Atty. Inaki P. Larrazabal, Jr., in answer to the popular request of local leaders and constituents to fill up the said vacancy considering that he is not only a lawyer who passed the bar with flying colors but also a Bachelor of Arts majoring in economics;

"WHEREAS, Atty. Larrazabal, young, energetic, dynamic and enthusiastic as he is, has earned the respect of this august Body due to his adequate training, expertise and experience in the arts of government being a Punong Barangay of Barangay Donghol and has been recently elected Vice-President of the Association of Barangay Councils;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to request His Excellency, President Ferdinand E. Marcos, through the Honorable Jose A. Roño, Minister of Local Government, to appoint Atty. Inaki P. Larrazabal, Jr., Kagawad ng Sangguniang Panlungsod ng Ormoc, vice - Kagawad Placido C. Enocio, deceased; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, and Hon. Jose A. Roño, Minister of Local Government, both in Metro Manila, and Atty. Inaki P. Larrazabal, Jr., Ormoc City;
