A RESOLUTION TO ADOPT RESOLUTION NO. 1928 OF THE HONORABLE
SANGGUNIANG PANLUNGSOD NG LAOAG

"WHEREAS, the Honorable Sangguniang Panlungsod ng Laoag had furnished us a copy of their Resolution No. 1928 dated May 24, 1982, respectfully requesting His Excellency, President Ferdinand E. Marcos, to grant the 13th-month pay of public school teachers all over the country;

"WHEREAS, we concur in the embodiment of Resolution No. 1928 of the Honorable Sangguniang Panlungsod ng Laoag that the school teachers are the most burdened public servants with low salaries and minimal benefits from the National Government even as we adhere to the maxim that they are next to parents in molding the youth to make them pillars of tomorrow;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Samson; be it

"RESOLVED, to adopt Resolution No. 1928 of the Honorable Sangguniang Panlungsod ng Laoag and do, as this Body hereby does, most respectfully request His Excellency, President Ferdinand E. Marcos, to grant the 13th-month pay to public school teachers all over the country; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, Manila; the Honorable Sangguniang Panlungsod, City of Laoag; the Division Superintendent of City Schools and the High School Principal, both of Ormoc City;
