A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATIONS ON COMMUNICATION SERVICES OF HIS
OFFICE AND OF THE CITY BUDGET OFFICER'S THE AGGREGATE SUM
OF P357.70 TO SETTLE OUTSTANDING OBLIGATIONS ON TELEPHONE
RENTALS WITH THE ORMOC CITY TELEPHONE COMPANY INCURRED
BETWEEN NOVEMBER AND DECEMBER, LAST FISCAL YEAR

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Torre-
villas, seconded by Kagawad Mendola;

"RESOLVED, to authorize the City Treasurer to charge against cur-
rent appropriations on communication services of: (a) his office, the
sum of P263.00 and (b) office of the City Budget Officer, the sum of
P94.70, both aggregating Three Hundred Fifty-Seven Pesos and Seventy
Centavos (P357.70), said sum or so much thereof as may be necessary
to be made available for settling outstanding obligations on tele-
phone rentals with the Ormoc City Telephone Company incurred between
November and December of last fiscal year; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Treasurer, the City Budget Officer, and the General Manager,
Ormoc City Telephone Company, all of this city;
