RESOLUTION NO. 1199

A RESOLUTION URGENTLY REQUESTING OUR ASSEMBLYMEN OF REGION VIII TO SUPPORT PARLIAMENTARY BILL 1542 AUTHORED BY ASSEMBLYMAN EMMANUEL PELAEZ

"WHEREAS, Parliamentary Bill 1542 authored by the Honorable Assemblyman Emmanuel Pelaez seeks to amend the revised charter of the National Power Corporation which contains provisions that militate against the basic policy of the State on electric power industry as laid down under PD Nos. 40 and 269, and because said provisions have been taken advantage of by the National Power Corporation per its Memorandum of Understanding with the Board of Investments entered into on January 12, 1982;

"WHEREAS, the basis of the NPC-BOI agreement aforecited is PD 395 which amended the NPC charter by, among other things, authorizing the NPC to sell power in bulk directly to industrial enterprises registered with the BOI instead of coursing such sale through electric cooperatives or private franchise holders;

"WHEREAS, PD 40 charges the NPC with power generation and transmission, and the electric cooperatives and other electric franchise holders with power distribution which is backed up by Section 39(b) of PD 269 providing that the National Power Corporation shall not, except upon prior written agreement approved by the electric cooperative's Board, compete in the sale of power and energy which will be utilized and consumed within any area franchised to a cooperative.';

"WHEREAS, Parliamentary Bill in effect restores the legal rights of electric cooperatives as franchise holders and also seeks to strengthen the financial viability of cooperatives by protecting them from undue copetition from the National Power Copporation; and

"WHEREAS, Parliamentary Bill 1542 once enacted into law will mullify the NPC-BOI agreement and, in addition, it aims to grant electric cooperatives through its umbrella organization, the Federation of Electric Cooperatives of the Philippines (FECOPHIL), a say in the matter of rates and royalties due the cooperatives;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad Santiago; be it

"RESOLVED, to urgently request our Assemblymen of Region VIII to support Parliamentary Bill 1542 authored by Assemblyman Emmanuel Pelaez; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Querube C. Makalintal, Speaker; Hon. Jose A. Roño, Majority Floor Leader; and the Honorable Assemblyman Emmanuel Pelaez, author of the bill; and the Honorable Assemblymen Emiliano Melgazo, Alberto A. Veloso, Fernando F. Veloso, Artemio Mate, Damian Aldaba, Edilberto del Valle, Victor Amasa and Nicanor Yñiguez of Region VIII, all in the Batasang Pambansa, Metro Manila;
