A RESOLUTION TO STRONGLY SUPPORT THE PASSAGE OF PARLIAMENTARY
BILL NO. 2255 INTRODUCED BY ASSEMBLYMAN CONCORDIO C. DIEL

"WHEREAS, the Honorable Assemblyman Concordio C. Diel had during the fourth regular session of the Batasang Pambansa introduced Parliamentary Bill No. 2255, otherwise known as An Act Increasing the Per Diems, Traveling Expenses and Daily Allowances of Government Officers and Employees When on Official Travel Within the Philippines, Amending for the Purpose Republic Act Numbered Thirty-Eight Hundred and Forty-Seven, as Amended";

"WHEREAS, this bill spells a ray of hope for officials and employees of the government after so many years of waiting for an increase of their traveling expenses while bearing for so long the brunt of the very high cost of living in metropolitan areas of destination;

"WHEREAS, the bill needs our support to become a law for the government employees to enjoy its benefits although it is long overdue;
