RESOLUTION NO. 1203

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO SIGN THE
MEMORANDUM OF AGREEMENT, OTHERWISE KNOWN AS THE BWP, MLG-CITY
AGREEMENT, WITH THE MINISTER OF LOCAL GOVERNMENT FOR
PURPOSES OF BARANGAY WATER PROJECTS

"WHEREAS, there is now being prepared the Memorandum of Agree-
ment, otherwise known as the Barangay Water Program (BWP), Ministry
of Local Government (MLG)-City Agreement to be signed by the Honora-
ble City Mayor for and in behalf of City of Ormoc and by the Minis-
ter of Local Government for and in behalf of the Ministry;

"WHEREAS, this agreement will redound to promote the social and
economic development of our barangays by implementing water projects
under the Barangay Water Program;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded joint-
ly by Mga Kagawad Mendola and Torrevillas; be it

"RESOLVED, to authorize the Honorable City Mayor to sign the
Memorandum of Agreement, otherwise known as the BWP, MLG-City Agree-
ment, with the Honorable Minister of Local Government for purposes
of the Barangay Water Projects; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Honorable Minister of Local Government, through the City De-
velopment Officer, the City Development Coordinator, the City En-
gineer, and the ABC President, all of Ormoc City;
