A RESOLUTION OF APPRECIATION AND THANKS TO HIS EXCELLENCY, PRESIDENT  
FERDINAND E. MARCOS, THROUGH POSTMASTER GENERAL J. ROILO GOLEZ,  
FOR THE DISPATCH OF INVESTIGATORS TO THE ORMOG CITY POST OFFICE

"WHEREAS, the City Administration owes a debt of gratitude to  
His Excellency, President Ferdinand E. Marcos, who, through Postmas-  
ter General J. Roilo Golez, immediately and promptly responded to  
the call of the Association of Barangay Councils, by its President,  
for an investigating team to probe certain malfeasance in the post  
office of Ormoc City on the heels of several complaints aired by  
many residents who fell prey to the post office's wrongdoings to  
the effect that mails from their relatives abroad are tampered with  
resulting in loss of checks or money orders and, sometimes, mails  
would never reach them;

"WHEREAS, the investigators have so efficiently attended to  
their chores that cases are now being filed with the Office of the  
City Fiscal for which the victims could heave a sigh of relief from  
anxiety and anguish over their lost mails;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by  
Kagawad Mendola; be it

"RESOLVED, to express our sincere appreciation and thanks to  
His Excellency, President Ferdinand E. Marcos, through Postmaster  
General J. Roilo Golez, for the dispatch of investigators to the  
post office of Ormoc City; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each  
to His Excellency, President Ferdinand E. Marcos, Malacañan Palace,  
and Gen. J. Roilo Golez, Postmaster General, both in Metro Manila;
