RESOLUTION NO. 1208

A RESOLUTION TO ALLOW THE KABATAANG BARANGAY FEDERATION OF ORMOC CITY TO HOLD A THREE-DAY "PINTAKASI" ON OCTOBER 14-16, 1982 AT THE VALENCIA SPORTS CENTER PROCEEDS OF WHICH TO BE MADE AVAILABLE FOR THE PROMOTION OF SPORTS AND YOUTH DEVELOPMENT

"WHEREAS, the Kabataang Barangay Federation of Ormoc City is in dire need of funds for the promotion of sports and youth development in the community such that they made representations with this august Body that they be allowed to hold a 'pintakasi' for three days from the 14th to the 16th of October, this year;

"WHEREAS, we find the request of the KB Federation meritorious considering that it is yet an infant organization which really needs funds for the prosecution of their project;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kagawad Bandalan; be it

"RESOLVED, to allow the Kabataang Barangay Federation of Ormoc City to hold a three-day 'pintakasi' on October 14, 15 and 16, 1982, at the Valencia Sports Center, a duly licensed establishment in Barangay Valencia, this city, the proceeds of which shall be made available for the promotion of sports and youth development; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Commanding Officer, 352nd Company, PC, the Station Commander, Integrated National Police, the President, Kabataang Barangay Federation, and the Proprietor, Valencia Sports Center, all in the City of Ormoc;
