RESOLUTION NO. 1211

A RESOLUTION TO OFFICIALLY RECOGNIZE THE HONORABLE MA. EMILY C. CODILLA, PRESIDENT OF THE ORMOG CITY FEDERATION OF KABATAANG BARANGAYS, AS THE TENTH MEMBER OF THE SECOND SANGGUNIANG PANLUNGSOD NG ORMOG, AND TO CONGRATULATE HER FOR ATTAINING SUCH A HIGH POSITION IN THE LOCAL GOVERNMENT
