RESOLUTION NO. 1220

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT  
DONATIONS BUT LIMITED TO ELEVEN OR TWELVE 20-WATT FLOURESCENT  
LAMPS FROM THE SANGGUNIANG BARANGAY OF JUATON FOR INSTALLATION  
ON THE BARANGAY STREETS PROVIDED THE BARANGAY WILL SHOULDER  
THE MAINTENANCE WHILE THE CITY SHOULDERS ELECTRICITY COST

"WHEREAS, the Sangguniang Barangay of Juaton, by its Resolution  
No. 1 of August 14, 1982, has signified their intention to donate  
some units of mercury vapor lamps the total wattage of which will be  
in excess of the allowable consumption for every barangay to be paid  
for by the city, such that the donations may be accepted provided  
they are limited to only eleven or twelve 20-watt flourescent lamps,  
for installation on the barangay streets of Juaton;

"NOW, THEREFORE, on motion of Kagawad Torre Villas, seconded joint-  
ly by Mga Kagawad Mendola and Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor to accept dona-  
tions but limited to eleven or twelve 20-watt flourescent lamps from  
the Sangguniang Barangay of Juaton for installation on the barangay  
streets: PROVIDED, However, that the barangay will shoulder the main-  
tenance thereof while the city shoulders the cost of electricity in  
line with the policy of the City Administration; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the President, Board of Directors, and the General Manager, both of  
LEYECO V, the City Engineer, the City Treasurer, and the Sangguniang  
Barangay of Juaton, all of this city;

"CARRIED UNANIMOUSLY."
