RESOLUTION NO. 1221

A RESOLUTION TO AUTHORIZE THE HONORABLE CRISTOBAL S. MENDOLA, IN
HIS CAPACITY AS CHAIRMAN ON PUBLIC PROPERTIES, TO NEGOTIATE
WITH LANDOWNERS IN BARANGAY CURVA FOR ACQUISITION OF THEIR LANDS
BY THE SANGGUNIANG BARANGAY FOR PURPOSES OF A BARANGAY SITE

"WHEREAS, the Sangguniang Barangay of Curva, by its Resolution
No. 2 dated June 15, 1982, has requested the Honorable Cristobal S.
Mendola, Kagawad-in-Charge of District VI, and, incidentally, Chair-
man of the Committee on Public Properties of this august Body, to
take charge of the land procurement, as has been promised by him
sometime ago, for purposes of a barangay site of Curva;

"NOW, THEREFORE, on motion of Kagawad Torre Villas, seconded by
Kagawad Bandalan; be it

"RESOLVED, to approve Resolution No. 2 of the Sangguniang Baran-
gay of Curva and do, as this Body hereby does, authorize the Honora-
ble Cristobal S. Mendola, in his capacity as Chairman on Public Pro-
perties, to negotiate with landowners in Barangay Curva for acquisi-
tion of their lands by the Barangay Sanggunian of Curva for purposes
of barangay site; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Honorable Cristobal S. Mendola, Chairman, Committee on Public
Properties, this Body, the Sangguniang Barangay of Curva and landown-
ers thereof involved, all of this city;

"CARRIED. Seven affirmative votes. One abstention registered by
Kagawad Mendola."
