RESOLUTION NO. 1223

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ACCEPT
THE DONATION OF ONE 20-WATT FLOURESCENT LAMP FROM MR. ASENSI
AND COMPANY FOR INSTALLATION IN SITIO LOOK, BARANGAY LINAO,
PROVIDED IT DOES NOT EXCEED THE ALLOWABLE WATTAGE FOR EVERY
BARANGAY OTHERWISE IT SHALL HAVE TO BE MAINTAINED AND BILLS
THEREFOR SHOULDERED BY THE SANGGUNIANG BARANGAY OF LINAO

"WHEREAS, Messrs. and Mesdames Santiago P. Asensi, Jr., Catalino
Tan and Maximo Orillano, in their joint letter have signified their in-
tention to donate one 20-watt flourescent lamp for installation on the
electric post in the interior area of Sitio Look, Barangay Linao, as it
is in pitch darkness specially during moonless nights such that it
is feared among the inhabitants of the area that it might become a re-
fuge of lawless elements if continued to be unlighted;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded jointly
by Mga Kagawad Samson and Santiago; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the do-
nation of one 20-watt flourescent lamp for installation in Sitio Look,
Barangay Linao, by Mr. Asensi and company; PROVIDED, However, that it
does not exceed the allowable wattage for every barangay otherwise it
shall have to be maintained and bills therefor shouldered by the Sang-
guniang Barangay of Linao; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the General Manager and the President, Board of Directors, both of
LEYECO V, the Barangay Sanggunian of Linao, and Mr. Santiago P. Asensi,
Jr., and company, all in Ormoc City;

"CARRIED UNANIMOUSLY."
