RESOLUTION NO. 1224

A RESOLUTION TO RESCIND RESOLUTION NO. 30, SERIES OF 1975, OF THE
SEVENTH MUNICIPAL BOARD, APPERTAINING TO LEASE OF 500 SQUARE
METERS OF LOT NO. 2245 AT THE GOVERNMENT CENTER SITE FOR THE
ORMOC MEDICAL SOCIETY FOR THE PURPOSE OF LEASING TO THEM ANO-
THER LOT, INSTEAD, TO BE NEAR ONE ANOTHER WITH THE PHILIPPINE
NATIONAL RED CROSS AND THE ORMOC DENTAL SOCIETY

"WHEREAS, this august Body has decided to concentrate the
clinics of the Ormoc Dental Society who asked for a lot for the
construction of their dental clinic and clubhouse and the Philip-
pine National Red Cross and the Ormoc Dental Society who have al-
ready been leased a lot each at the Government Center site, such
that there is a need to rescind Resolution No. 30, series of 1975,
of the Seventh Municipal Board, appertaining to the lease of 500
square meters of Lot No. 2245 at the Government Center site for
the Ormoc Medical Society;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by
Kagawad Torre Villas; be it

"RESOLVED, to rescind Resolution No. 30, series of 1975, of
the Seventh Municipal Board, appertaining to the lease of 500 square
meters of Lot No. 2245 at the Government Center site for the
Medical Society for the purpose of leasing to them another lot,
instead, to be near one another with the Philippine National Red
Cross and the Ormoc Dental Society; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the City Engineer, the City Treasurer, and the President, Ormoc
Medical Society, all of this city;

"CARRIED UNANIMOUSLY."
