RESOLUTION NO. 1225

A RESOLUTION TO RESCIND RESOLUTION NO. 282 OF THE FIRST SANGGUNIANG
PANLUNGSD AFFECTING THE DONATION OF 552 SQUARE METERS OF LOT NO.
3961 AT THE GOVERNMENT CENTER SITE TO THE PHILIPPINE NATIONAL
RED CROSS FOR THE PURPOSE OF LEASING, INSTEAD, ANOTHER LOT TO BE
NEAR ONE ANOTHER WITH THE ORMOC MEDICAL AND DENTAL SOCIETIES

"WHEREAS, it has been decided that the clinics of the Ormoc Dental
Society, the Philippine National Red Cross, and the Ormoc Medical Socie-
ty shall be concentrated in one area so that there is a need to rescind
Resolution No. 282 of the First Sangguniang Panlungsod affecting the do-
nation of 552 square meters out of Lot No. 3961 at the Government Center
site to the Philippine National Red Cross for the establishment of their
blood bank;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad
Codilla, be it

"RESOLVED, to rescind Resolution No. 282 of the First Sangguniang
Panlungsod affecting the donation of 552 square meters out of Lot No.
3961 at the Government Center site to the Philippine National Red Cross
for the purpose of leasing, instead, another lot to be near one another
with the Ormoc Medical Society and the Ormoc Dental Society; and be it

"RESOLVED, FURTHER, to furnish a copy of this Resolution each to
the Administrator, Leyte Chapter, PNRC, Tacloban City, through the Of-
ficer-In-Charge, PNRC Blood Bank, and to the City Engineer and the City
Treasurer, all in Ormoc City;
