RESOLUTION NO. 1226

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO LEASE TO
THE ORMOC DENTAL SOCIETY, THE PHILIPPINE NATIONAL RED CROSS,
AND THE ORMOC MEDICAL SOCIETY 500 SQUARE METERS AT A MINIMAL
RATE OF ONE PESO PER ANNUM EACH, RESPECTIVELY, FOR FIFTY
YEARS OUT OF LOTS NOS. 2223, 2235 AND 2247 AT THE GOVERNMENT
CENTER SITE PROVIDED THAT THE SAID PROPERTY, INCLUDING ALL
IMPROVEMENTS THEREON, SHALL BE RETURNED TO THE CITY IF THE
LESSEES HAVE NO MORE USE FOR THE SAME

"WHEREAS, this august Body has decided to concentrate the clinics
of the Ormoc Dental Society, the Philippine National Red Cross, and
the Ormoc Medical Society along a road at the Government Center site,
preferably in succession from the lot of the Bureau of Telecommunica-
tions for the convenience of the needy patients availing themselves
of the free services of these humanitarian organizations;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kaga-
wad Codilla; be it

"RESOLVED, to authorize the Honorable City Mayor to lease to the
Ormoc Dental Society, the Philippine National Red Cross, and the Ormoc
Medical Society 500 square meters at a minimal rate of one peso per an-
num each, respectively, for fifty years out of Lots Nos. 2223, 2235 and
2247 at the Government Center site, to be concentrated in succession
from the lot of the Bureau of Telecommunications westward: PROVIDED,
HOWEVER, That the property, including all improvements thereon, shall
be returned to the City if the lessees have no more use for the same;
and be it

"RESOLVED FURTHER, to furnish a copy of this resolution each to
the Administrator, Leyte Chapter, PNRC, Tacloban City; the City En-
gineer, the City Treasurer, the Presidents of the Medical and the Den-
tal Societies and the Officer-in-Charge, PNRC Blood Bank, all in Ormoc
City;

"CARRIED UNANIMOUSLY."
