RESOLUTION NO. 1229

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE FIRST LADY AND HUMAN SETTLEMENTS MINISTER IMELDA ROUNALDEZ-MARCO, THROUGH THE HONORABLE ENERGY MINISTER GERONIMO VELASCO, TO CAUSE THE IMPROVEMENT OF ELECTRIC SERVICES OF THE NATIONAL POWER CORPORATION THROUGH LEYCO V SERVING ORMOG CITY AND THE NEIGHBORING MUNICIPALITIES

"WHEREAS, it is a sad experience that for quite a time now the electricity in Ormoc City and neighboring municipalities supplied by the National Power Corporation through the Leyte V Electric Cooperative Services (LEYCO V) has been very inadequate resulting in mal-functioning and even breaking down of appliances to the prejudice of the consuming public;

"WHEREAS, early in the evening the lights hardly illuminate to its rated wattage such that appliances cease to function due to low voltage supplied to customers but at about ten or eleven o'clock in the evening the voltage suddenly rises up to more than the recommended line voltage thus breaking down appliances and equipment;

"WHEREAS, this electric service deficiency or irregularity is probably due to either lack of coordination of the NPC with LEYCO V or lack of the necessary equipment such that, if this kind of service will continue, the people might resort to filing claims for damages of broken down appliances and equipment;

"NOW, THEREFORE, on motion of Kagawad Torre Villas, seconded by Kagawad Mendola; be it

"RESOLVED, to earnestly request the Honorable First Lady and Human Settlements Minister Imelda Rounaldez-Marco, through the Honorable Energy Minister Geronimo Velasco, to cause the improvement of electric services of the National Power Corporation through the LEYCO V servicing Ormoc City and the neighboring municipalities; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Madam Imelda Rounaldez-Marco, Honorable First Lady and Minister of Human Settlements, Malacañang, and Hon. Geronimo Velasco, Minister of Energy, both in Metro Manila; the Project Manager, NPC, the President of the Board and the General Manager, both of LEYCO V, and all of this city;

"CARRIED UNANIMOUSLY."
