RESOLUTION NO. 154, S. 1973, OF THE SEVENTH MUNICIPAL BOARD,
BY CHANGING THE NUMBER OF THE SPECIAL CIVIL CASE FROM 1114-0
TO 1273-0 BEING AN AMENDED EXPROPRIATION PROCEEDINGS WITH
THE COURT OF FIRST INSTANCE AFFECTING TWO (2) HECTARES OF
LOT NO. 1770 OF THE HEIRS OF ANGEL TAN FOR PURPOSES OF THE
ESTABLISHMENT OF THE MULTI-PURPOSE CENTER IN BARANGAY SAN
ANTONIO.
