RESOLUTION NO. 1232

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MINISTER
OF PUBLIC HIGHWAYS FOR THE CONCRETING OF STILL UNPAVED
PORTIONS OF THE ORMOG-KANANGA ROAD TO THE NORTH AND
ORMOG-ALBUERA ROAD TO THE SOUTH.

"WHEREAS, there are still portions of the national highway which
up to the present remain unpaved such as those passing through Baran-
gays Simaingan, Catayum, Cabulihan, Cagbuhagin and Valencia along
Ormog-Kananga Road to the north and Bantigue, Ipil, San Antonio and
Macabug along Ormog-Albuera Road to the south which are becoming ha-
zards to motorists or drivers even as they cause discomfort and in-
convenience to travelers, specially tourists, considering that these
are parts of the Maharlika highway connecting Ormog City to Metro
Manila;

"NOW, THEREFORE, on motion of Kagawad Torre Villas, seconded una-
nimously by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Honorable Minister of Public
Highways for the concreting of still unpaved portions of the Ormog-
Kananga Road to the north and Ormog-Albuera Road to the south; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Honorable Minister of Public Highways Jesus Hipolito, the Honorable
Minister of Human Settlements Imelda Romualdez-Marcos, and the Honorable
Minister of Tourism Jose D. Aspiras, all in Metro Manila; the Regional
Director of Public Works and Highways, Candahug, Palo, Leyte; and the
City Engineer, Ormog City;
