A RESOLUTION TO REQUEST THE CITY PLANNING AND DEVELOPMENT STAFF TO
COORDINATE WITH THE SANGGUNIANG COMMITTEE ON PUBLIC PROPERTIES
IN THE MAKING OF A MASTER PLAN FOR THE COMPLETE DEVELOPMENT OF
THE ORMOC CITY GOVERNMENT CENTER SITE.

"WHEREAS, there is a need to have a master plan for the complete
development of the Ormoc City Government Center Site where government
offices may be concentrated in an area and some entities in another
area for the convenience of the general public;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Bandalan and Hermosilla; be it

"RESOLVED, to request the City Planning and Development Staff to
coordinate with the Committee on Public Properties of the Sangguniang
