"WHEREAS, the Officer In-Charge of the Assessment Department has  
requested passage of a resolution to authorize the Honorable City Ma-  
yor to enter into a Cost Share Reimbursement Agreement with the Minis-

and the Ministry will share the burden of expenses on 50-50 basis in  
our tax mapping project in line with Phase II of the Real Property  
Tax Assessment (RPTA) Program;
