A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE
REPLACEMENT OF THE FISH, MEAT AND VEGETABLE SECTION G.I.
ROOFING OF THE ORMOG CITY PUBLIC MARKET COMPLEX WITH A
RIB-5 FORMING ROOFING BY THE PHILIPPINE RIGID CONSTRUCTION
COMPANY AS CERTIFIED AS WORK ACCOMPLISHED PER CERTIFICATE
ISSUED BY THE OFFICE OF THE CITY ENGINEER

"WHEREAS, after having inspected the Replacement of the Fish,

Market Complex with a Rib-5 Forming Roofing contracted by the Phi-
