RESOLUTION NO. 1242

A RESOLUTION TO ENDORSE TO THE REGIONAL DIRECTOR OF PUBLIC WORKS
AND HIGHWAYS THE PROGRAM OF WORK AND BILL OF MATERIALS FOR
THE REPLACEMENT OF WATER PIPELINE FROM ANILAO SPRING, BARANGAY
MILAGRO, DOWN TO UPPER COGON, PASSING THROUGH BARANGAYS DOLORES,
CONCEPCION, JUATON, DAYHAGAN AND SIMANGAN, FOR REVIEW AND FUNDING.

"WHEREAS, the Officer-In-Charge and Ex-Officio Public Works City
Engineer, in his second communication dated September 27, 1982, has
submitted the amended program of work and bill of materials for the
replacement of water pipeline from Anilao Spring, Barangay Milagro,
down to upper Cogon, passing through Barangays Dolores, Concepcion,
Juaton, Dayhagan and Simangan, amounting to P300,000.00;

"WHEREAS, the replacement is to be made inasmuch as the pipeline
was destroyed during the cementing and improvement of the Ormoc-Mila-
gro road under the supervision and management by the Ministry of Pub-
lic Works and Highways;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Mendola and Torrevillas; be it

"RESOLVED, to endorse to the Regional Director of Public Works
and Highways the Program of Work and Bill of Materials for the Re-
placement of Water Pipeline from Anilao Spring, Barangay Milagro,
down to Upper Cogon, passing through the Barangays of Dolores, Con-
cepcion, Juaton, Dayhagan and Simangan; for review and funding; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Regional Director, Ministry of Public Works and Highways,
Pawing, Palo, Leyte; the Officer-In-Charge and Ex-Officio PW City
Engineer, Ormoc City;
