RESOLUTION NO. 1244

A RESOLUTION TO GRANT THE WORLD SAFETY ORGANIZATION TO HOLD A
DAY COCK DERBY (NOV. 18, 19, 20, 1982) AT THE NADUNGHOLAN
COCKPIT, SUBJECT TO THE IMPLEMENTING RULES AND REGULATIONS
OF THE PHILIPPINE GAMEFOWL COMMISSION, FOR PURPOSES OF
W.S.O. MEMBERSHIP AND FUND CAMPAIGNS OF 1982.

"WHEREAS, the Office of the Mayor has forwarded to this august
Body the request of the President-Director General of the World Safe-
ty Organization for a resolution granting the organization to hold a
three days' cock derby at this city in its effort to meet the required
goal out of the proceeds in order to promote safety and accident pre-
ventions by way of its Educational Membership and Fund Campaigns as au-
thorized by the President of the Philippines in Proclamation No. 2190;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded by Kaga-
wad Bandalan; be it

"RESOLVED, to grant the World Safety Organization to hold a three-
day cock derby on November 18, 19 and 20, 1982, at the Nadungholan Cock-
pit, a duly licensed establishment in Ormoc City, subject, however, to
the implementing rules and regulations of the Philippine Gamefowl Com-
mission, for purposes of the W.S.O. Educational Membership and Fund
Campaigns of 1982; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Mr. Emiliano L. Camarillo, President-Director General, World Safety Or-
ganization, Laong Laan Building, Pasay City Hall Complex, Metro Manila;
the Regional Director, Philippine Gamefowl Commission, Tacloban City;
the Station Commander, Integrated National Police, and the Manager,
Nadungholan Cockpit, both in Ormoc City;
