RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR OF PUBLIC
WORKS AND HIGHWAYS TO ALLOCATE AT LEAST 12 CLASSROOMS FOR ORMOC
CITY OUT OF THE 109 UNITS ALLOCATED FOR REGION-WIDE DISTRIBUTION

"WHEREAS, the Officer In-Charge of the City Engineering Office
in his letter of October 6, 1982, has underscored the dire necessi-
ty for additional classrooms such that he suggested that this august
Body make representations with the Regional Director for the release
or allocation of at least twelve (12) classrooms for Ormoc City out
of the 109 classrooms allocated for region-wide distribution accord-
ing to the 1983 MPWH Infrastructure Program for Region VIII;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded by
Kagawad Mendola; be it

"RESOLVED, to earnestly request the Regional Director of Public
Works and Highways to allocate at least 12 classrooms for Ormoc City
out of the 109 units allocated for region-wide distribution under the
1983 MPWH Infrastructure Program for Region VIII; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Regional Director, Ministry of Public Works and Highways, Paving,
Palo, Leyte; the City Engineer, and the City Schools Division Superin-
tendent, both in Ormoc City;
