RESOLUTION NO. 1248

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ACCEPT THE
DONATION OF THE SANGGUNIANG BARANGAY OF NAUNGAN OF TWO 20-WATT
INCANDESCENT BULBS FOR INSTALLATION ON THE ELECTRIC LIGHT POSTS
OF PUROK 6 AND PUROK 7 PROVIDED THEY DO NOT EXCEED THE ALLOWA-
BLE WATTAGE FOR BARANGAYS AND SHALL BE MAINTAINED BY THE
SAID SANGGUNIANG BARANGAY.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Her-
mosilla, seconded by Kagawad Samson;

"RESOLVED, to authorize the Honorable City Mayor to accept the
donation of the Sangguniang Barangay of Nauñgan of two units of 20-
watt incandescent bulbs for installation on the electric light posts
of Purok 6 and Purok 7 of the said barangay: Provided, however, That
they shall not exceed the allowable wattage for barangays and that
the same shall be maintained by the Sangguniang Barangay of Nauñgan;

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Resident Manager and the President of the Board of Directors,
both of LEYECO V, and the Sangguniang Barangay of Nauñgan, all in
the City of Ormoc;
