"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Minister of Health, Metro Manila; the Regional Director, Ministry of Health, Tacloban City; His Honor, the City Mayor, and the Chief of Hospital, Ormoc General Hospital, both of Ormoc City.
