RESOLUTION NO. 1252

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO EXECUTE A DEED  
OF DONATION OF THE PRESENT SITE OCCUPIED BY THE ORMOG GENERAL HOS-  
PITAL, WITH AN AREA OF 20,000 SQUARE METERS, KNOWN AS LOT NO. 11766  
(FORMERLY LOT NO. 5364-B) SITUATED IN COGON COMBADO, IN FAVOR OF  
THE MINISTRY OF HEALTH, PROVIDED, THAT THE LATTER SHOULD RETURN THE  
LOT INCLUDING ALL IMPROVEMENTS THEREON, TO THE CITY GOVERNMENT IF  
THE SAME WOULD NO LONGER BE USED.

"The City Sangguniang Panlungsod, on motion of Kagawad Mendola,  
seconded by Kagawad Samson;

"RESOLVED, to authorize the Honorable City Mayor to execute a  
Deed of Donation of the present site occupied by the Ormoc General  
Hospital, with an area of 20,000 square meters, known as Lot No. 5364-B  
now Lot No. 11766, situated in Cogon Combado, in favor of the Ministry  
of Health; PROVIDED, However, that should the Ministry of Health no  
longer use this lot, said lot, including all the improvements thereon,  
should be returned to the City Government;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the Honorable Minister of Health, Metro Manila; the Regional Director,  
Ministry of Health, Tacloban City; His Honor, the City Mayor, and  
the Chief of Hospital, Ormoc General Hospital, both of Ormoc City.
