RESOLUTION NO. 1255

A RESOLUTION URGENTLY REQUESTING THE HONORABLE MINISTER OF NATURAL
RESOURCES, THROUGH THE DIRECTOR OF THE BUREAU OF FOREST DEVELOP-
MENT, THE DIRECTOR OF PUBLIC WORKS AND HIGHWAYS, THE DIRECTOR OF
TOURISM, ALL OF REGION VIII, TO ALLOW ORMOC CITY TO PROCEED WITH
THE CONSTRUCTION OF GAAS-LIBERTY ROAD

"WHEREAS, according to information, the construction of Gaas-
Liberty road was stopped for the reason that it will conflict with
the program of the Leyte Nature Hiking Trail and the Ministry of
Tourism;

"WHEREAS, Barangay Liberty is the remotest barrio of Ormoc City
such that opening the Liberty-Gaas Road is of great importance to
the residents of both barangays and will greatly help the residents
of barangay Liberty;

"WHEREAS, the road is the only farm-to-market road making accessi-
ble for the residents of Barangay Liberty and Gaas in transporting their
produce to Ormoc City;

"WHEREAS, that adequate funding has already been appropriated for
this very important project;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Mendola and Hermosilla; be it

"RESOLVED, to urgently request the Honorable Minister of Natural
Resources, through the Director of Forest Development, the Director
of Public Works and Highways and the Director of Tourism, all of
Region VIII, to allow Ormoc City to proceed with the construction of
Gaas-Liberty Road; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Honorable Minister of Natural Resources, Metro Manila; the
Honorable Directors of Forest Development, Public Works and High-
ways and Tourism, all of Region VIII, Tacloban City; and the City
Engineer, Ormoc City;
