RESOLUTION NO. 1256

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO SIGN THE
CONTRACT WITH THE CODILLA'S ENTERPRISES, WINNING BIDDER, FOR
THE CONSTRUCTION OF THE ORMOC SUB-FIRE STATION ON S. PEDRO ST.

"WHEREAS, the construction of a sub-fire station has been our com-
mitment to Fire Brig. Gen. Primo Cordita who also committed himself to
allocate either an aerial ladder fire truck or a pumper fire truck, or
both for which we have planned the sub-fire station to be constructed
on San Pedro Street;

"WHEREAS, the bidding had already been made with the Codilla's En-
terprises as the winning bidder such that the contract is now being pre-
pared in connection with the said construction;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Mendola and Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor to sign the con-
tract, for and in behalf of the City Government, with the Codilla's En-
terprises for the construction of the Ormoc Sub-fire Station on San
Pedro Street; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Fire Brig. Gen. Primo Cordita, Fire Marshal of the Philippines, Camp
Crame, Q.C., Metro Manila; the City Engineer, the Fire Station Command-
er, and the Manager, Codilla's Enterprises, all in the City of Ormoc;

"CARRIED. Six affirmative votes; one abstention registered by Ka-
gawad Codilla; Kagawad Samson was out during the voting."
