RESOLUTION NO. 1264

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ENTER INTO
A CONTRACT WITH THE PHILIPPINE RIGID CONSTRUCTION CORPORATION,
WINNING BIDDER, FOR THE CONSTRUCTION OF THE ORMOG SHOPPING MALL.

"WHEREAS, the Honorable Dionisio S. Santiago who represents this
august Body in the Pre-qualification Bidding and Award Committee (PBAC)
reported that in the opening of bids last Friday, November 5, 1982, the
Philippine Rigid Construction Corporation of Mandaue City came out as
the winning bidder and, therefore, the construction of the Ormoc Shop-
ping Mall is being awarded to the said corporation for which a contract
will soon be prepared for the purpose;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Mendola and Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor, for and in be-
half of the Government of Ormoc City, to enter into a contract with
the Philippine Rigid Construction Corporation, winning qualified bid-
der, for the construction of the Ormoc Shopping Mall; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Chairman, Pre-qualification Bidding and Award Committee (PBAC),
the City Engineer, the City Treasurer, the City Auditor, and the Mana-
ger, Philippine Rigid Construction Corporation (Mandaue City), and the
City Legal Officer, all in Ormoc City;
