A RESOLUTION TO RESERVE LOTS NOS. 99, 98, 97 AND PORTION OF LOT
NO. 96 FOR PURPOSES OF A BARANGAY SCHOOL SITE OF BARANGAY 25

"WHEREAS, the Barangay 25 Sanggunian in its Resolution No. 3, current series, has requested the City Administration to provide them with a suitable area for a school site and construction of classrooms;

"WHEREAS, Barangay 25, being a resettlement area, is also the relocation center of squatters from Barangays 18, 16 and Buenavista, and wherein lies Lots Nos. 99, 98, 97 and portion of Lot No. 96 which can be available for the much needed barangay school site where the school-house or classrooms may be constructed for the ultimate welfare of the children of allocatees;

"RESOLVED, to reserve Lots Nos. 99, 98, 97 and portion of Lot No. 96 for purposes of a barangay school site of Barangay 25; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the Punong Barangay of Barangay 25, and the Draftsman (Mr. Patricio C. Marson, Jr.), Assessment Department, all of Ormoc City;
