"RESOLVED, to endorse Resolution No. 866 of the Honorable Sangguniang Panlungsod ng Davao requesting the Batasang Pambansa that the election of local officials scheduled for the year 1986, which is the expiry year of the terms of office of local officials elected in the year 1980, be synchronized with the election for President of the Philippines in 1987, instead of synchronizing the same with the 1984 elections of Batasan Members, so as not to prejudice the said elective local officials who have been mandated by the people to serve for six (6) years; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Sangguniang Panlungsod, Davao City; Hon. Benjamin Romualdez, Governor of Leyte, Tacloban City; and all Assemblymen of Region VIII;
