WORKS AND HIGHWAYS, THROUGH THE REGIONAL DIRECTOR, TO RELEASE CER-
TAIN SUMS FOR ORMOG CITY OUT OF APPROPRIATION ITEMS FOR REGION VIII
OR NATIONAL APPROPRIATIONS UNDER BATAS PAMBANSA BLG. 132

"WHEREAS, Ormoc City is in dire need of funds for the much-needed
improvement of our pier, our drainage system, and shore protection;

"WHEREAS, Batas Pambansa Blg. 132 provides for Region VIII, among
others, the following:

Page 6 - C-2. Commercial Ports, P29,000,000.00 (National
appropriation, P200,000,000.00)
Page 13 - Item 41. Ormoc City Drainage System, P10,000,000.00
Page 15 - Title G. Shore Protection, P9,000,000.00;

for P2,700,000.00 for the improvement of our pier, P10,000,000.00 for
our city drainage system, and P1,000,000.00 for our shore protection
projects;
