RESOLUTION NO. 1273

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE
DONATION OF 14 FLUORESCENT LAMPS FROM THE SANGGUNIANG BARANGAY
OF LUNA FOR INSTALLATION ON ELECTRIC POSTS WITHIN THE BARANGAY

"WHEREAS, the Barangay Sanggunian of Luna in its Resolution No.
01 has signified their intention to donate fourteen tubes of fluores-
cent lamps; (11 at 20 watts each and 3 at 10 watts each) for installa-
tion on electric posts within the barangay;

"WHEREAS, the lamps to be donated will aggregate 250 watts which
is the allowable wattage for every barangay to be shouldered by the
City even as the barangay pledges to maintain said lighting;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kaga-
wad Mendola; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the
donation of 14 fluorescent lamps from the Sangguniang Barangay of
Luna for installation on electric posts within the barangay; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the General Manager and the President, Board of Directors, both
of LEYECO V, the City Engineer, the City Treasurer, and the Barangay
Sanggunian of Luna, all in Ormoc City;
