RESOLUTION NO. 1277

A RESOLUTION GRANTING THE GIRL SCOUTS OF THE PHILIPPINES, ORMOC CITY CHAPTER, TO SPONSOR A 3-DAY "PINTAKASI" ON DECEMBER 22, 23 AND 24, 1982, AT THE MADONGOLAN COCKPIT, SUBJECT TO THE IMPLEMENTING RULES AND REGULATIONS OF THE PHILIPPINE GAMING COMMISSION, FOR THE PURPOSE OF SPONSORING THE GIRL SCOUTS DELEGATION OF ORMOC CITY IN THEIR PARTICIPATION IN THE NATIONAL ENCAMPMENT IN NOVALICHES, QUEZON CITY

"WHEREAS, Mrs. Lilia B. Davis, Girl Scout Coordinator of Area V, in her letter of November 26, 1982, has requested this august body to be granted to sponsor a 3-day 'pintakasi' on December 22, 23 and 24, 1982, at the Madongolan Cockpit the proceeds of which shall be made available in sponsoring the Girl Scouts delegation of Ormoc City for the National Encampment at Novaliches, Quezon City;

"WHEREAS, we find the request of the Girl Scout Coordinator most worthy of consideration as it is geared towards socio-cultural development of our girl scouts;

"NOW, THEREFORE, on motion of Kagawad Sarsen, seconded by Kagawad Codilla; be it

"RESOLVED, to grant the Girl Scouts of the Philippines, Ormoc City Chapter, to sponsor a 3-day 'pintakasi' on December 22, 23 and 24, 1982, at the Madongolan Cockpit, a duly licensed establishment in Ormoc City, subject, however, to the implementing rules and regulations of the Philippine Gaming Commission, for the purpose of sponsoring the Girl Scouts Delegation of Ormoc in their participation in the National Encampment in Novaliches, Quezon City; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Philippine Gaming Commission, Tacloban City; the Station Commander, Integrated National Police, the Area V Girl Scouts Coordinator, and the Proprietor, Madongolan Cockpit, all in Ormoc City;
