RESOLUTION NO. 1278

A RESOLUTION TO ABOLISH ALL STANDING COMMITTEES OF THE SECOND

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kaga-  
wad Bandalan; be it

"RESOLVED, to abolish all standing committees of the Second Sang-  
guniang Panlungsod ng Ormoc and do, as this Body hereby does, declare  
vacant all positions of chairmen, vice-chairmen and members thereof,  
repealing for this purpose Resolutions Nos. 790 and 1101 of this Body;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
His Honor, the City Mayor, the Honorable Vice-Mayor and Presiding Of-  
ficer and all Members (Mga Kagawad) of the Second Sangguniang Panlung-  
sod, Ormoc City;
