RESOLUTION NO. 1279

A RESOLUTION TO REAPPORTION ORMOC CITY INTO ELEVEN (11) REPRESENTATIVE DISTRICTS AMONG THE PRESIDING OFFICER AND ALL THE MEMBERS (MGA KAGAWAD) OF THE SECOND SANGGUNIANG PANLUNGSOD NG ORMOC, AMENDING FOR THIS PURPOSE RESOLUTIONS NOS. 791 AND 940

"WHEREAS, we have now two (2) new Members (Mga Kagawad) of this august Body who have not as yet been assigned to any representative district such that it behooves this august Body to reapportion Ormoc City into eleven (11) (from 9) representative districts in order that the new Members, namely, Mga Kagawad Iñaki P. Larrazabal, Jr., and Ma. Emily C. Codilla, can be given each a district;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Bandalan and Hermosilla; be it

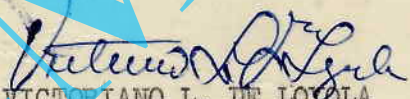
