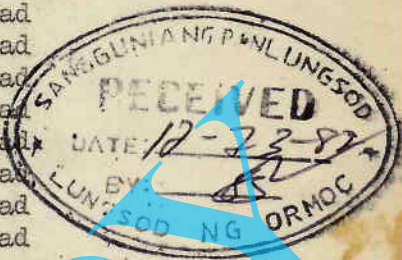

RESOLUTION NO. 1285

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ACCEPT THE
ORMOC CITY SUB-FIRE STATION CONSTRUCTION AS COMPLETED BASED
ON THE CERTIFICATE OF WORK ACCOMPLISHED AND TIME ELAPSED OF
THE CITY ENGINEER

"WHEREAS, the City Engineer has on December 14, 1982, issued a
Certificate of Work Accomplished and Time Elapsed on the construction
of the Ormoc City Sub-fire Station on San Pedro Street in response to
the request of the contractor after having completed the project;

"NOW, THEREFORE, on motion of Kagawad Torre Villas, seconded by
Kagawad Besabella; be it

"RESOLVED, to authorize the Honorable City Mayor, for and in be-
half of the City Government, to accept the Ormoc City Sub-fire Station
construction as completed based on the Certificate of Work Accomplish-
ed and Time Elapsed submitted by the City Engineer; and be it
