RESOLUTION NO. 1290

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO EXECUTE A  
DEED OF DONATION IN FAVOR OF THE BUREAU OF EQUIPMENT FOR  
PURPOSES OF THE AREA EQUIPMENT DEPOT IN ORMOC CITY COVERING  
AN AREA OF 1650 SQUARE METERS OF LOT NO. 2243 SITUATED AT  
THE GOVERNMENT CENTER PROVIDED, HOWEVER, THAT THE SAME SHOULD  
BE RETURNED TO THE CITY SHOULD THE BUREAU OF EQUIPMENT HAVE  
NO MORE USE FOR IT, TOGETHER WITH ALL IMPROVEMENTS THEREON.

"WHEREAS, the Area Equipment Engineer has requested additional  
area to cover space deficiency for equipment depository which serves  
not only the city and district engineering offices but also Naval en-  
gineering district of Biliran sub-province;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kaga-  
wad Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor, for and in be-  
half of the Government of Ormoc City, to execute a deed of donation in  
favor of the Bureau of Equipment for purposes of the Area Equipment  
Depot (Area 5) in Ormoc City covering an area of one thousand six hun-  
dred fifty (1650) square meters of Lot No. 2243 situated at the Govern-  
ment Center: PROVIDED, However, That the same, together with all the  
improvements thereon, should be returned to the City of Ormoc should  
the Bureau of Equipment have no more use for it; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the Honorable Minister of Public Works and Highways, Port Area, Metro  
Manila; the Regional Director, Bureau of Equipment, Kandahug, Palo,  
Leyte; the Area Equipment Engineer, the City Engineer, the City Deve-  
lopment Coordinator, and the City Treasurer, all in Ormoc City;
