RESOLUTION NO. 1291

A RESOLUTION OF RECOMMENDATION TO THE HONORABLE CITY MAYOR FOR THE SANGGUNIANG BARANGAY OF VALENCIA TO USE 204 SQUARE METERS OF LOT NO. 8418 OF THE CITY GOVERNMENT ADJACENT TO THE VALENCIA PUBLIC MARKET SITE FOR THE ERECTION OF A BARANGAY HALL, PROVIDED THAT THE SAID CITY PROPERTY SHALL REVERT TO THE CITY, INCLUDING ALL THE IMPROVEMENTS THEREON, SHOULD THE BARANGAY HAVE NO MORE USE FOR THE SAME.

"WHEREAS, the Sangguniang Barangay of Valencia, by its Resolution No. 17, series of 1982, has, through the Honorable City Mayor, requested this august Body to permit them to use the vacant portion of lot adjacent to the Valencia public market site, notably, City Lot No. 8418 whereon to construct their barangay hall;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Bandalan, Santiago and Hermosilla; be it

"RESOLVED, to recommend to the Honorable City Mayor for the Sangguniang Barangay of Valencia to use 204 square meters of Lot No. 8418 of the City Government adjacent to the Valencia Public Market site for the erection of a barangay hall, said city lot being bounded as follows: on the NE. by Juanito Yap street measuring 17 meters, on the S. by the remaining portion of the said lot, on the NE. by the old market site measuring 12 meters, on the W. by B. Codilla street measuring 12 meters: PROVIDED, However, That the said city property shall revert to the City, including all the improvements thereon, should the Barangay of Valencia have no more use for the same; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Engineer, the City Development Officer, and the Sangguniang Barangay of Valencia, all in Ormoc City;

"CARRIED UNANIMOUSLY."
