RESOLUTION NO. 1292

Larrazabal, Jr., there is a need to abolish all standing committees to give way to the creation of new committees;

"RESOLVED, to abolish all standing committees of the Second Sangguniang Panlungsod ng Ormoc and do, as this Body hereby does, declare vacant all chairmanships, vice-chairmanships and memberships thereof, rescinding for the purpose Resolutions Nos. 790 and 1101 to give way to the creation of new committees; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Honor, the City Mayor, the Honorable Vice-Mayor and Presiding Officer and Mga Kagawad of the Sangguniang Panlungsod, all departments and offices and all Sangguniang Barangays, Ormoc City;
