
"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad Tugonon; be it

"RESOLVED, to create thirty-one (31) standing committees of the Second Sangguniang Panlungsod ng Ormoc, as follows: the Steering Committee, the Committees on Agriculture and Agrarian Reform, Cities Sisterhood Program, Cottage Industries, Education and Culture, Energy Development and Conservation, Environmental Control, Finance, General Services, Good Government, Health and Public Welfare, Infrastructure, Internal Rules, Labor, Laws and Ordinances, Manpower Development, Markets and Slaughterhouses, Natural Resources Conservation and Development, Police, Fire and Public Safety, Public Information, Public Properties, Rural Development, Social Welfare, Sports Development, Tourism and Cultural Development, Trade and Commerce, Transportation and Communications, Urban Development, Ways and Means, Youth Development, and Zoning and Beautification; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Honor, the City Mayor, the Honorable Vice-Mayor and Presiding Officer and the Kagawads of the Sangguniang Panlungsod, all departments and offices and all Sangguniang Barangays, in the City of Ormoc;
