RESOLUTION NO. 1296 A RESOLUTION EARNESTLY REQUESTING PROC-EDC TO REINSTATE TERMINATED EMPLOYEES CONSIDERING THAT THE LATTER HAVE ALREADY RI THEIR POSITIONS AS BARANGAY OFFICIALS TO CLING TO THEIR JOBS IN THE CORPORATION.

"WHEREAS, numerous barangay ex-officials have requested this august Body to intercede for them with the PNOC-EDC that they be reinstated to their posts in the corporation considering that they have already resigned their elective positions to stick it out with the PNOC-EDC;

"WHEREAS, these ex-officials of their respective barangays, being well-known in their communities, were urged to run and they won having then no knowledge of implication by circumstances of their being considered public officials in the employ of a government corporation as they then lacked adequate information;

"WHEREAS, having been duly informed by way of a PNOC memorandum that being public officials their employment in a government corporation is impermissible, these barangay officials chose the better part of prudence to resign their respective elective positions in order to retain their posts in the FNOC-EDC;

"WHEREAS, despite their resignation from their elective government positions the PNCC-EDC still terminated their services to their prejudice and humiliation;

"WHEREAS, in fairness to these people who faithfully served the PNOC-EDC but whose services were terminated by the latter through no fault of their own they ought to be reinstated to their posts considering that they are no longer connected with the barangay government service;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by gawad Torrevillas; be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Pablo Malixi, Vice-President, PNOC-EDC, Port Bonifacio, Metro Manila; Engr. Ernesto B. Patanao, Project Manager, PNOC-EDC, Tufigonan, Ormoc City, and the President, Association of Barangay Captains (ABC), Ormoc City;
