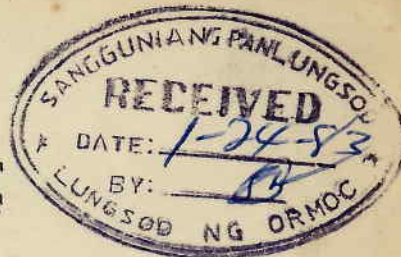

RESOLUTION NO. 1297

A RESOLUTION AUTHORIZING THE CITY LEGAL OFFICER TO FILE AN EXPROPRIATION CASE FOR EMINENT DOMAIN OVER LOT NO. 6080-B, ORMOG CADASTRE, AS SEGREGATED BY THE CITY GEODETIC ENGINEER, COVERED BY T.C.T. NO. 5480-PART OF THE REGISTER OF DEEDS OF ORMOG CITY WITH AN AREA OF 7,939 SQUARE METERS IN THE NAME OF MR. & MRS. GREGORIO CATAAG SITUATED IN BARANGAY AIRPORT FOR PURPOSES OF A BARANGAY SCHOOL SITE, AVAILING HIMSELF OF THE BARANGAY FUND.

"WHEREAS, the Sangguniang Barangay of Airport by its Resolution No. 1, current series, has requested the Honorable City Mayor, through this august Body, to cause the filing of an expropriation proceeding to acquire 7,939 square meters of Lot No. 6080-B, as segregated by the City Geodetic Engineer, after negotiations with the owners, Mr. & Mrs. Gregorio Cataag, failed to acquire it through a negotiated sale for the establishment of a school site of Barangay Airport; considering that the Barangay Airport has sufficient fund for said purpose;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Torrevillas; be it

"RESOLVED, to authorize the City Legal Officer to file an expropriation case for eminent domain over Lot No. 6080-B, Ormoc Cadastre, as segregated by the City Geodetic Engineer, covered by Transfer Certificate of Title No. 5480-part of the Register of Deeds of Ormoc City with an area of 7,939 square meters in the name of Mr. & Mrs. Gregorio Cataag situated in Barangay Airport for purposes of a barangay school site, availing himself of the barangay fund for said purpose; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Legal Officer, the City Treasurer, the Sangguniang Barangay of Airport, and Mr. & Mrs. Gregorio Cataag of Cantubo, all in Ormoc City;
